Supplementary Regulations

- Midlands Trials Car Club will organise a Clubman's Historic Sporting Trial at, "Trials Field" opposite Sywell Aerodrome, Wellingborough Road, Sywell, Northampton, NN6 0BN on Sunday 9th Feburary 2020
- 2. This meeting will be held under the General Regulations of the Motorsports UK (incorporating the provisions of the International Sporting Code of the FIA), and these Supplementary Regulations.
- 3. Motorsport UK Permit No. TBC has been issued.
- 4. The event is open to all fully elected members of the organising club and BTRDA, NPTCC, 750 Motor Club, MCC, HSCC, VSCC, MAC, Stroud and District MC, KBCC, Southsea Motor Club Ltd, Woolbridge MC, Falcon Motor Club, Midlands Trials Car Club and Golden Valley HLCC..
- 5. BOTH Drivers and Passengers must produce a valid Motorsport UK Licence (minimum RS Clubman's) and be a member of Motorsport UK Registered Club, at signing on.
- 6. Scrutineering starts at 9.00am, situated near signing on.
- 7. First hill at 10.30am. Any competitor not signed on by 10.15am may be excluded.
- 8. The trial will consist of at least three rounds of six hills. The entry will be split into groups starting on different hills. Start hills will be determined by ballot. No practicing allowed. Competition numbers will be issued by the organisers. Double drives and shared drives are permitted please fill in two entry forms.
- 9. Awards will be presented as follows, subject to a minimum of four starters in each class. Organisers reserve the right to reallocate awards:
